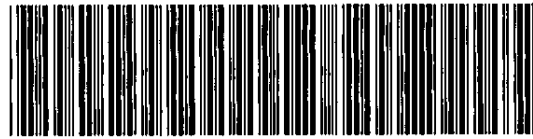

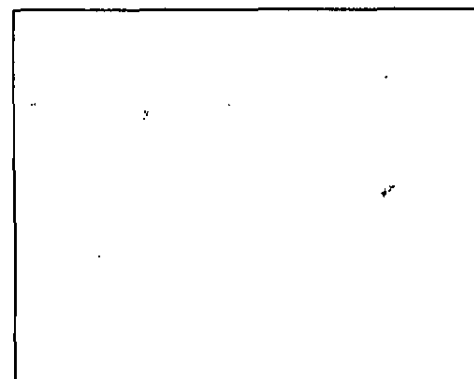

The undersigned does hereby execute, acknowledge and file the following Amendment to the Articles of Incorporation of THE WELLNESS COMMUNITY-GREATER MIAMI, INC.

1. The name of the Corporation is currently:

2. The date of the filing of the Articles of Incorporation was July 1, 1999.
3. The Articles of Incorporation are amended as follows:
 - a. By deleting all of Article I hereof, and by substituting in lieu thereof, all of the following:

“The name of the corporation shall be CANCER SUPPORT COMMUNITY GREATER MIAMI, INC. Its principal place of business shall be 8609 South Dixie Highway, Miami, Florida 33143, and the mailing address shall be the same.”
 - b. In all other respects, the Articles of Incorporation shall remain unchanged.
