**AMENDMENT TO ARTICLES OF INCORPORATION
OF
DAYTONA GAY PRIDE, INC.**

The Board of Directors of Daytona Gay Pride, Inc., by unanimous vote taken on April 4, 2000, and pursuant to the Agreement to Amend, which has been incorporated into the minutes of this corporation, hereby amends the Articles of Incorporation as follows:

1. To amend Article III of the Articles of Incorporation by deleting the current article and replacing it with the following new Article III:

**ARTICLE III
PURPOSES**

This Corporation is organized under the provisions of Chapter 617, Florida Statutes, relating to corporations not-for-profit, for the following purposes:

(a) The organization is organized exclusively for charitable, religious, educational, and/or scientific purposes under Section 501 (c) (3) of the Internal Revenue Code.


(b) No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization except from federal income tax under Section 501 (c) (3) of the Internal Revenue Code, or corresponding

section of any future federal tax code, or (b) by an organization, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

(c) The organization has neither members nor members entitled to vote.

2. In all other respects, the original Articles of Incorporation filed herein on July 6, 1999, are reaffirmed.
