## ARTICLE IV is hereby amended to read:

The governing body shall be the Board of Trustees. The initial Trustees are elected by the members and are
appointed for life according to the Emir system in Islam. Upon death, abdication of office or removal of a
Trustee, then the Trustee shall be replaced by a vote of the majority of the Board of Trustees according
to the By-Laws. A Trustee is expected to be a sane practicing Muslim and shall take full responsibility
for the position to which he is appointed. The Board of Trustees shall be the Supreme governing body
and shall not be replaced by any other persons, groups, bodies or organizations by any means.
The Board of Directors as described in Article IV of the Articles of Organization shall remain in existence but
shall be governed by the Board of Trustees as provided for in the Amended By-Laws of the corporation.
The Chairman of the Board of Trustees shall be the leader of the Board of Trustees and authorized to
act on behalf of the corporation and shall be authorized to sign documents on behalf of the corporation.
