We, the undersigned subscribers to these Articles of Incorporation, each a natural person, competent to contract, hereby make, subscribe, acknowledge and file these Articles for the purpose of becoming a corporation not for profit pursuant to Chapter 617.0202, Florida Statutes.

ARTICLE I. NAME

The name of the corporation shall be Christ The Church of Tampa, Inc.

ARTICLE II: PLACE OF BUSINESS

The principal place of business shall be in the County of Hillsborough, State of Florida as determined by the Board of Directors. The mailing address is: 1224 E. 142nd Avenue, Tampa, Florida 33613.

ARTICLE III: PURPOSE

The purpose for which this corporation not for profit is organized is as follows:

1. To provide Healthy Socialization of community members by means of relevant support groups.
2. To provide Biblical as well as extra-biblical teachings communicated by respected teachers and other effective social leaders.

3. To provide educational tutoring, recreation and outreach focusing on meeting spiritual and physical needs.

ARTICLE IV: BOARD OF DIRECTORS

The Board of Directors shall consist of not less than five(5) and no more than nine(9) individuals from the community.

The Board of Directors shall be elected at the annual meeting of the directors and each directors shall hold office for a term of two(2) years and until his or her successor is duly elected and qualified or until his or her death, resignation or removal.

Each person named in the Articles of Incorporation as a member of the initial Board of Directors shall hold office for an initial term of one(1) year and until his or her successor shall have been elected and qualified or until his or her earlier resignation, removal from office of death.

ARTICLE V: REGISTERED AGENT

The registered agent of this corporation shall be Alecia Roundtree, 1224 E. 142nd Avenue, Tampa, Florida 33613.

ARTICLE VI: TERM OF EXISTENCE

This corporation not for profit shall have perpetual existence.

ARTICLE VII: OFFICERS

The officers of the corporation shall be the President, Vice-

President, Secretary and Treasurer and other officers as provided by the By-Laws.

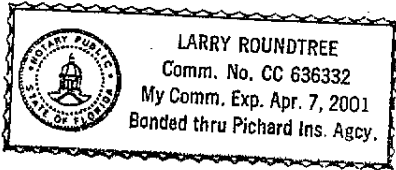




