**ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a pursuant to chapter 617, Florida Statutes, adopts the following articles of incorporation of such corporation.

ARTICLE I

The name of the corporation shall be: **SOCIEDAD DOMINICANA DE LA FLORIDA CENTRAL, INC.** The principal place of business of this corporation shall be:

ARTICLE II

The period of the duration of this corporation is Perpetual unless dissolved according to law.


