ARTICLES OF INCORPORATION

**FIRST:** The name of this corporation is The Church of Jesus Christ (International/Interracial), Inc.

**SECOND:** Its principal office in the State of Florida is to be located at 4301 46<sup>th</sup> Avenue South, St. Petersburg, FL 33711, Pinellas County.

**THIRD:** The corporation is organized exclusively for religious purposes. The purpose of the corporation shall be to minister to the physical and spiritual needs of people, regardless of nationality or race, based on the spiritual principles, as expressed in the Holy Bible and exemplified by Jesus Christ.

**FOURTH:** The Board of Trustees shall manage the activities and affairs of the corporation. Trustees are selected from the membership of the corporation whenever vacancies arise based on death, resignation or removal as set forth in the Bylaws. The initial Board of Trustees shall have three (3) members whose names and addresses are as follows:

The number of trustees may be raised by amendment of the bylaws of the corporation but shall in no case be less than three.

**FIFTH:** This is a nonstock, nonprofit corporation. The purpose of the corporation is to engage in any lawful act or activity for which nonprofit corporations may be organized under the Florida Not For Profit Corporation Act (Chapter 617).
