ARTICLES OF INCORPORATION

SECRETARY OF STATE

FIRST: The name of this corporation is The Church of Jesus Christ (International/Internacial), Inc.

**SECOND:** Its principal office in the State of Florida is to be located at 4301 46<sup>th</sup> Avenue South, St. Petersburg, FL 33711, Pinellas County.

**THIRD:** The corporation is organized exclusively for religious purposes. The purpose of the corporation shall be to minister to the physical and spiritual needs of people, regardless of nationality or race, based on the spiritual principles, as expressed in the Holy Bible and exemplified by Jesus Christ.

**FOURTH:** The Board of Trustees shall manage the activities and affairs of the corporation.
