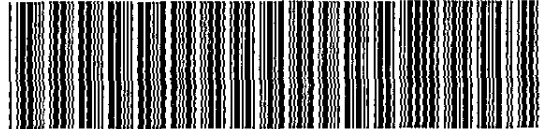

SECOND: The document number of the corporation: N99000004119


THIRD: Adoption of Dissolution
