ARTICLES OF INCORPORATION

ARTICLE I

Name

Section 1. This Corporation shall be known as **Larry White Ministry, Incorporated**, and shall be located within the geographical boundaries of Miami-Dade County, Florida. This corporation is wholly owned by the Officers and Members of Larry White Ministry, Incorporated. This corporation is not a subsidiary in whole or in part of the Connectional African Methodist Episcopal Church.

ARTICLE II

Purpose

Section 1. The purpose of the corporation shall be to address the physical, spiritual, educational, social and economic welfare of its members and the surrounding community.

Section 2. This Trust has been organized as a not for profit Corporation according to the laws of the State of Florida.

ARTICLE III

Officers

Section 1. The Officers of Larry White Ministry, Incorporated, Incorporated shall consist of a President, Vice-President, Secretary and Treasurer.

Section 2. The term of the Officers shall be for two (2) years, commencing June 1, 1999 and terminating on May 31, 2001 of the second year.

Section 3. A special election shall be held to elect a replacement to complete the unexpired term of the Vice-President, Secretary and Treasurer in the event these officers do not complete any full term of office.

ARTICLE IV

Board of Directors

Section 1. The members of the Board of Directors shall be elected by a majority of the Board.

Section 2. The members of the Board of Directors shall serve two (2) year terms. Terms of the Board shall commence on June 1, 1999 and terminate on May 31, 2001 of the second year.

Section 3. Board Members who have three (3) consecutive unexcused absences may be removed by a majority vote of a quorum of the Board. Excused absences are determined solely by the Officers of the Board.

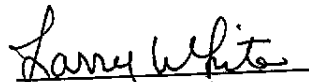

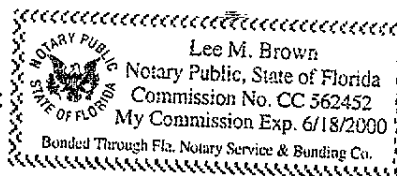
