ARTICLES OF INCORPORATION

OF

PEOPLE WHO JUST DON'T WANT HIGHER TAXES, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME OF THE CORPORATION

The name of the corporation (the "Corporation") shall be: People Who Just Don't Want Higher Taxes, Inc.

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and the mailing address of this Corporation shall be 2060 Biscayne Boulevard, Second Floor, Miami, FL 33137.

ARTICLE III

PURPOSES

The purposes for which this corporation is to be formed are as follows:

- (a) To evaluate, promote, sponsor and campaign against proposed State sales tax increases;
- (b) To provide a meaningful and active voice in the affairs affecting the South Florida Community;
- (c) To exercise all powers that are or may hereafter be conferred upon corporations formed under Chapter 617 of the Florida Statutes, and to do any and all such other acts and things necessary, desirable or appropriate to carry out or accomplish any of the purposes of this corporation.

ARTICLE IV

DIRECTORS

The business and affairs of the Corporation shall be managed by and under the direction of a Board of Directors, which shall consist of not more than three (3) persons, each of whom shall be at least eighteen (18) years of age. The exact number of Directors may be increased or decreased by a Board of Directors' resolution, but shall never be fewer than one (1) Director. The manner in which the Directors are elected or appointed is provided in the ByLaws of the Corporation.

ARTICLE V




