Articles of Incorporation of Chumuckla Hunting Club, Inc.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

#### Article I - Name

The name of this corporation will be Chumuckla Hunting Club, Inc. 3901 Molino Rd.
Molino, FL 32577

Article II - Registered Agent and Office

The street address of the initial registered office of this corporation is 3901 Molino Rd., Molino, FL 32577, and the name of the registered agent of this corporation at that address is Marvin Luther Griffey.

## Article III - Purpose

The purpose of this corporation will be to provide and maintain for the benefit of the corporation's members, hunting, sporting, and recreational facilities and opportunities. Said purposes will be accomplished in any manner provided under the laws of the State of Florida, but will not be for pecuniary profit.

#### Article IV - Qualification and Admission of Members

Persons qualified for membership in this corporation will be all persons sixteen (16) years of age or older and eligible for insurance of a State of Florida hunting license. Each person seeking membership into the corporation will first be recommended for membership to the Board of Directors by a member in good standing of the corporation. The Board of Directors will approve or disapprove of the persons membership.

# Article V - Membership Dues

Membership dues, special assessments, fines, penalties, and forfeitures will be fixed or assessed by the Board of Directors from time to time, at least annually. All such dues, assessments, penalties, fines, and forfeitures will be paid, failing which, the membership of such will be terminated.

Article VI - Amendment of Article of Incorporation

These articles may be amended by a majority vote of the Board of the corporation.

#### Article VII - Terms of Existence

This corporation is to exist perpetually.
