The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I**

The name of the corporation shall be:

SOUTH FLORIDA CRICKET FOUNDATION, INC.

**ARTICLE II**

This corporation shall exist perpetually unless dissolved according to Florida law.

**ARTICLE III**

The corporation is organized exclusively as a non-profitable foundation. This corporation will conduct organized youth training and development in the game of cricket. The corporation will conduct coaching, demonstrations, summer programs, tournaments and camps. The corporation will be supported solely by fund raising and sponsorship.
