AMMENDMENT TO ARTICLES OF INCORPORATION

ARTICLE VIII Said corporation is organized exclusively for charitable, religious, and educational purposes, including for such purposes, making of distributions to organizations under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.


No part of the earnings of the corporation shall inure to the benefit of, or be distributed to its members, trustees, directors, officers or any other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future Federal tax code)

Upon dissolution of this corporation, if the named recipient is not in existence or no longer a qualified distributee or unwilling or unable to accept the distribution, then the assets of this corporation shall be distributed to a fund, foundation or corporation organized and operated exclusively for the purposes specified in section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code).
