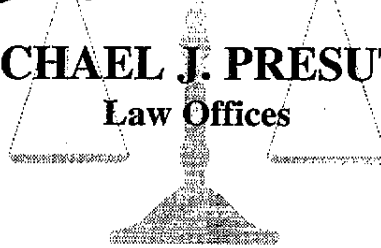

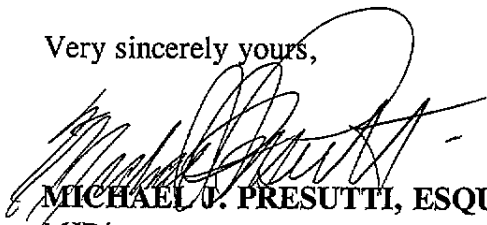

ARTICLES OF INCORPORATION
OF
LUKE INTERNATIONAL MINISTRIES, INC.
A FLORIDA NONPROFIT CORPORATION

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be Luke International Ministries, Inc.

ARTICLE II - GENERAL NATURE OF BUSINESS

The general nature of the organization is to provide free medical care for the needy individual, group, or organization and to promote the gospel of Jesus Christ around the world. To achieve this goal, the organization will solicit contributions from individuals, organizations, institutions, and pharmaceutical companies in the form of cash, medicine, and supplies or medical services. All contributions will be acknowledged and recorded immediately as they are received.

ARTICLE III - SPECIFIC PURPOSE OF ORGANIZATION

The specific purposes of the organization is:

- A. To provide spiritual guidance and to teach and reveal the saving grace of the Lord Jesus Christ to those who are willing.
- B. To provide medical care directly to the needy, including medical, surgical care and advise for further medical care and referral to appropriate medical specialties and institutions.
- C. To provide assistance to charity clinics and medical institutions for the training of

medical students in forms of medical expertise, medical supplies, equipment, books, periodicals and other appropriate provisions.

D. To provide financial aid to person(s) who will contribute their skills but are not able to cover their personal expenses during the mission activities.

E. To plan and schedule the mission activities in a 3-5 year period, and assign the personnel involved at least one year before the actual mission.

F. To gather, categorize, pack, and store supplies at an appropriate location, to ship supplies to authorized individuals or organizations duly recognized by the State or Country where the mission is directed.

G. To have and exercise all rights and powers conferred on nonprofit corporations under the laws of the State of Florida, or which may hereafter be conferred; provided, however that this corporation shall not, except to an insubstantial degree, engage in any activity or exercise any power that is not in furtherance of the primary purpose of this corporation.

ARTICLE IV - DURATION

This corporation shall exist perpetually until dissolved according to the law; and the corporate existence will commence on the filing of these articles with the Department of State.

ARTICLE V - PRINCIPAL OFFICE AND ADDRESS

The street address and the mailing address of the principal office of this corporation is 7221 Aloma Avenue, Suite 400B, Orlando, Florida, 32792.

ARTICLE VI - REGISTERED OFFICE AND AGENT

The initial registered office of the corporation shall be located at 7221 Aloma Avenue, Suite 400B, Orlando, Florida, 32792. The name of the initial registered agent to accept service of process at that address is E. Roger Alilin, MD.

ARTICLE VII - DIRECTORS

The method of election of the directors of the corporation is set forth in the bylaws.

ARTICLE IX - ADDITIONAL CORPORATE POWERS


In furtherance, and not in limitation of the general powers conferred by the laws of the State of Florida and of the purposes and objects hereinabove stated, this corporation shall have all and singular the following powers:

A. To enter into, or become a partner in, any arrangement for, union of interest, or cooperation, joint venture or otherwise, with any person, firm, or corporation, to carry on any business which this corporation has the direct authority or incidental authority to pursue, provided that it not adversely affect its nonprofit status.

B. To enter into, for the benefit of its Executive Officers of the organization, the

following: a pension plan, retirement, or incentive compensation plan.

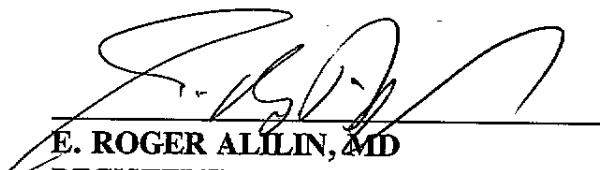
