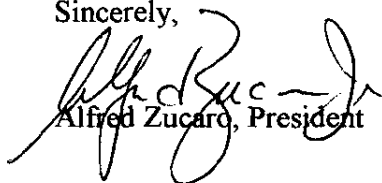
Dear Ms. Beauchamp:
