1.    **Name.**       The name of the corporation is RESCUE RECOVERY OUTREACH MINISTRY, INC.
2.    **Duration.**   The period of duration is perpetual.
3.    **Purpose.**     The purpose is to carry out the biblical mandate of the Great Commission as perceived through the eyes of Jesus Christ, to witness and to evangelize the unsaved, and to organize and build a body of "born again" believers whose lives reflect changes to confessed Christianity. Also, to dispense the gift of teaching and the preaching of God's Word.
