**ARTICLES OF INCORPORATION
OF
RIVER OF REVIVAL CHURCH INC
A NOT-FOR-PROFIT CORPORATION**

I, Gillroy M. Howard-Browne, the undersigned acting as incorporator for the purpose of creating a non profit corporation pursuant to Chapter 617 of the State of Florida Statutes, do hereby set forth the following Articles of Incorporation:

ARTICLE 1. The name of the corporation is River of Revival Church Inc.

ARTICLE 2. The corporation is a Religious corporation.

The principle place of business of this corporation shall be :
953 Audrey Court, Tallahassee, Florida 32311

The mailing address of this corporation shall be :
P.O. Box 14896, Tallahassee, Florida 32317-4896

ARTICLE 3. The corporation shall have perpetual duration.

ARTICLE 4. The purposes for which the corporation is organized are:

a. To preach the gospel of Christ as contained in the Holy Bible and to minister the Word of God to a local body of believers, organize church related functions, activities and propagate the beliefs as contained in the Statement of Faith and engage in religious services, worship services, evangelistic outreach, evangelistic crusades, missions, and international revival / evangelistic meetings and to acquire and hold both real and personal property for Church purposes and engage in any activity or business permitted under the laws of the United States and the State of Florida.

b. To assist both financially and organizationally in the setting up of new churches of similar persuasion and working with churches of other

denominations.

c. The purpose for which River of Revival Church is organized are exclusively religious, charitable, and/or educational purposes which will qualify it as an exempt organization within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

d. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

e. No part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation, or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.

ARTICLE 5. The corporation shall have members which may be divided into such classes as shall be provided in the bylaws. All members shall be accepted, appointed, elected or designated in the manner provided in the bylaws.

ARTICLE 6. The directors of the corporation shall be elected or appointed in the manner and for the terms provided in the Bylaws.

ARTICLE 7. No part of the net earnings of the corporation shall inure to the benefit of any officer, director or member of the corporation except for the compensation of services rendered as agreed upon by the compensation committee as laid out in the By-Laws. Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the corporation, dispose of the residual assets of the corporation exclusively for the stated purposes of the corporation in such

manner, or to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding Sections of any future Internal Revenue Code. Any such assets not so disposed of shall be disposed of by the Superior Court of the county in which the principal office of the corporation is then located, for such purposes or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

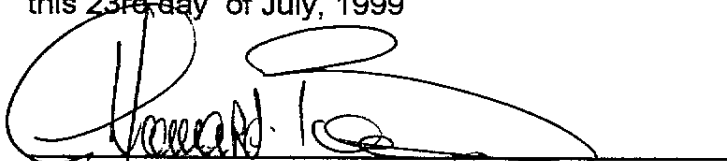
