The undersigned incorporator, for the purpose of forming a corporation under the Florida rida 3 JII 6 PH 2:45 Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: The Master's House Ministries, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSES

The specific purposes for which the corporation is organized are:

- To disseminate the Gospel of Jesus Christ and the Word of God; to the end that people may be A. evangelized in this country and in any and all other countries and that peoples in the world and believers may be conformed to the image of Jesus Christ.
- To regularly assemble together the members of this Corporation for fellowship, one with another, both В. in large public congregations and in small fellowship groups in houses and other places, to worship God in Spirit and in truth and to cooperate in the building up of the whole Body of Christ.
- To provide basic New Testament discipleship to all who are approved for this purpose by the Board of C. Directors.
