AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE NEXT STEP CENTER, INC.

Pursuant to the provisions of Section 617.1006, Florida Statutes, the Articles of Incorporation of the above-named corporation (the "Corporation"), filed with the Department of State on July 27, 1999, and assigned Charter Number N99000004459, are hereby amended pursuant to a written consent in lieu of meeting executed by all of the Corporation's Directors on the 31 day of May, 2000 as follows:

ARTICLE I

Article 11, Section 11.1 is hereby amended to read as follows:

11.1 Disposition of Assets. In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Article 501(c) (3) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future law, or to the Federal State or local Government for exclusive public purpose.

ARTICLE II

This not for profit corporation does not have members and is not a membership corporation.

ARTICLE III

This Amendment to the Articles of Incorporation was unanimously adopted by the Board of Directors of the Corporation on the 3/ day of MAY, 2000, and this vote cast was sufficient for approval of this Amendment to the Articles of Incorporation.

ARTICLE IV

The undersigned, being the President and Secretary of The Next Step Center, Inc., hereby certify that the above and foregoing Amendment to the Articles of Incorporation was adopted as aforesaid on the 3/ day of MAY, 2000.
