### ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Flor for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

# ARTICLE I

The name of the corporation shall be SOUTH FLORIDA PUERTO RICAN-LATINO COALITION, INC.

#### ARTICLE II

The principal place of business and mailing address of this corporation shall be 18011 NW 66 Court Circle, Miami, Florida 33015.

#### ARTICLE III

The purposes for which the Corporation is organized are as follows:

1. To research, plan and implement innovative programs which will enhance the, cultural, educational and economic interests of citizens of Puerto Rican and Latino heritage who reside in the South Florida communities of Miami-Dade, Broward and Palm Beach counties.

To this end the corporation will, among other things, solicit sponsors, grants and donations, and will organize cultural activities, community and business development projects as well as establish a scholarship fund to benefit students from the constituent groups who reside in the communities of South Florida.

- 2. The Corporation is organized exclusively to perform charitable and educational purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code.
- 3. To do everything necessary, suitable, or proper for the accomplishment, attainment, or furtherance of, and to do every other act or thing incidental to, appurtenant to, growing out of, or connected with the purposes, objectives, or powers set forth in these Articles of Incorporation. To possess all the rights, powers and privileges now or hereafter conferred by the laws of the State of Florida upon a general not-for-profit corporation organized under the laws of the State of Florida.

# ARTICLE IV

The method of election of directors will be stated in the corporation's bylaws.
