**ARTICLES OF INCORPORATION
OF

A FLORIDA NON-PROFIT CORPORATION**

The undersigned incorporator for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopts the following Articles Of Incorporation.

ARTICLE ONE - NAME

The name of the corporation shall be ST JUDE FOUNDATION INC.

ARTICLE TWO - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: P.O. Box 470326, Celebration, Florida 34747-0326.

ARTICLE THREE - PURPOSES

Said corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to individual homebuyers, as well as to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE FOUR - OFFICERS

The officers shall consist of a President, Secretary, and a Treasurer. This non-profit corporation may have such other officers as may be provided in the corporate Bylaws. The officers named herein, comprise the initial officers, shall hold office until the election of officers at the first annual Board of Directors' meeting.

ARTICLE FIVE - MANNER OF ELECTION OF DIRECTORS

This corporation shall elect its directors annually. The manner of the election of the directors shall be specified in the corporate Bylaws.

ARTICLE EIGHT - PERIOD OF EXISTENCE

The period of existence of this corporation shall be perpetual.

ARTICLE NINE- AMENDMENT OF ARTICLES OF INCORPORATION

The articles of incorporation of the corporation may be amended from time to time by a majority vote of all directors voting by written ballot in person or by proxy held at any general or special meeting of directors upon lawful notice

ARTICLE TEN - NON-PROFIT STATUTES

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE ELEVEN - DISSOLUTION OF CORPORATION

Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code. The bylaws provides a dissolution provision for the assets of this corporation.

ARTICLE TWELVE - INDEMNIFICATION

To the full extent permitted by law this corporation should indemnify and hold harmless its director, officer employee, or agent, and any of its former officer, director, employee, or agent from any actions they take on behalf of the Corporation.

ARTICLE THIRTEEN - AMENDMENT

This corporation reserves the right to amend or repeal any provisions in these Articles of Incorporation, or any amendments hereto.

I hereby accept my designation as registered agent and agree to serve as the registered agent of St Jude Foundation Inc a Florida Non Profit Corporation. I hereby state that I am familiar with and accept the duties and responsibilities as registered agent for St Jude Foundation Inc a Florida corporation.


