

ARTICLES OF INCORPORATION

of

SAVED TO SERVE MINISTRIES, INC.

a Non-Profit Corporation

The undersigned, acting as incorporator(s), of a Corporation pursuant to Chapter 617, Florida Statutes, the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation of such corporation:

Article I

The name of the corporation shall be: SAVED TO SERVE MINISTRIES, INC.

Article II

The principle place of business address of this corporation shall be: 802 Plumosa Avenue, Fruitland Park, Lake, Florida 34731.

The principle place of mailing of this corporation shall be: Post Office Box 323, Fruitland Park, Lake, Florida 34731.

Article III

The specific purpose(s) for which the corporation is organized is(are):

A. To establish a religious organization to teach and disseminate religious and charitable materials and/or services to the public, including, but not limited to, materials and/or services relating to the Holy Scriptures, through sermons, seminars, community outreach services, or otherwise.

B. This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

C. The purpose of this corporation is to engage in any lawful act or activity for which corporations may be organized under the Florida Not for Profit Corporation Act.

Article IV

The manner in which the directors are elected or appointed is: at an organizational meeting called by the incorporator.

Article V

The name and Florida street address of the initial registered agent are: Kelly Anthony Morris, 802 Plumosa Avenue, Lake, Florida 34731

Article VI

The name and address of the Incorporator(s) to these Articles of Incorporation are: Kelly Anthony Morris & Ussanta Morris, 802 Plumosa Avenue, Fruitland Park, Lake, Florida 34731

Article VII

The period of duration of this corporation is: perpetual.

Article VIII


Additional Provisions:


A. The property of this corporation is irrevocably dedicated to religious and charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefits of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a non-profit fund, foundation, or corporation which is organized and operated exclusively for religious and/or charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

B. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation [except as otherwise provided by Section 501(h) of the Internal Revenue Code], and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.


C. No part of the net earnings of this corporation shall inure to the benefits of, or distributable to, its members, directors, officers, or other private person, except that this corporation shall authorize and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in these Articles.


D. Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.
