ARTICLES OF INCORPORATION
OF
STILL WATER CHRISTIAN LIFE CENTER, INC.
(A Corporation Not-For-Profit)

We, the undersigned, do hereby associate ourselves together for the purpose of forming a body corporate, under the laws of the State of Florida, and by and under the provisions of Chapter 617 of the Florida Statutes providing for the formation, liabilities, rights and immunities of a corporation not-for-profit and hereby adopt the following articles of incorporation:

ARTICLE I
NAME

The name of the corporation shall be: STILL WATER CHRISTIAN LIFE CENTER, INC., and the principal place of business of this corporation shall be: 3105 Masee Road, Davenport, Florida 33837.

ARTICLE II
PURPOSES

The general nature of the purposes, and objects of this corporation will be for the purpose of religious worships, and for carrying on of such other church functions that the congregation may deem necessary and proper; to acquire, mortgage and sell property or properties in connection with its functions as a religious corporation.

ARTICLE III
QUALIFICATIONS OF MEMBERS

Qualification and admission into this organization will be as follows:

1. A personal commitment by grace through faith along in Jesus Christ for salvation. (Ephesians 2:8,9).
2. Baptism by immersion as a testimony of salvation.
3. Completion of the church membership class.
4. A commitment to abide by the membership covenant.
5. No person shall be qualified for membership in STILL WATER CHRISTIAN LIFE CENTER, INC. who holds an active membership in any organization or religious group whose fundamental doctrines are contrary to the doctrine adopted by STILL WATER CHRISTIAN LIFE CENTER. If a person desires membership with STILL WATER CHRISTIAN LIFE CENTER, INC. and is associated with such an organization, whether active or inactive, such a person must renounce all involvement forever and renounce all curses spoken over himself and his household. Renunciation of active involvement shall be by letter or such other means approved by the Pastoral Ministry Team.

Designation of membership.

In an effort to properly review the membership of the church, two rolls shall be maintained.

1. Active and resident members (members who reside within the church's ministry area, are currently active in the church, and are abiding by the membership covenant).

2. Non-resident members (members who have become inactive as a result of moved out of the church's ministry area and have not joined another church).

The members of this corporation shall be the subscribers, and such other persons as may from time to time be elected to membership by the members of the corporation.

ARTICLE IV TERM OF EXISTENCE

The period of the duration of this corporation is perpetual, unless dissolved according to law.

ARTICLE V BOARD OF TRUSTEE

The number constituting the initial Board of Trustee of the corporation is four (4), and the names and addresses of the persons who are to serve initially are:

Section I. No part of the net earnings of the corporation shall inure to the benefit of any individual or member.


Section II. No person, firm or corporation shall ever receive any dividends or profits from the undertaking of this corporation,
