Please accept this letter as notice of the dissolution of the Association of Professional Hospitality Managers (APHM), a Florida non profit corporation, as of December 31, 2001.

The original Florida Articles of Incorporation were filed and established on July 29, 1999 Returned — (see attached). Please reference FEI number 59-3623062. As of this filing for dissolution we are aware of no debts that remain unpaid.
