## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SUMMERFIELD AT BAYSIDE LAKES HOMEOWNERS ASSOCIATION, INC.

Pursuant to the provisions of §617,1006, Fla. Stat., SUMMERFIELD AT BAYSIDE LAKES HOMEOWNERS ASSOCIATION, INC. ("Association") adopts the following Articles of Amendment to its Articles of Incorporation.

## FIRST: Amendment adopted:

Article 8, Sections 8.0 and 8.1 of the ARTICLES OF INCORPORATION OF SUMMERFIELD AT BAYSIDE LAKES HOMEOWNERS ASSOCIATION, INC. Are hereby amended as follows (additions are indicated by underlining; deletions are indicated by strike-outs, omitted and unaltered provisions are indicated by ellipses):

## ARTICLE 8 **DIRECTORS**

- 8.0 The affairs and property of the Association shall be managed and governed by a Board of Directors composed of not less than three (3) Directors. The first Board of Directors shall have three (3) members, and the number of Directors on subsequent Boards will be determined from time to time in accordance with the provisions of the By-Laws of the Association.
