The undersigned incorporators, for the purpose of forming a corporation under the ASSEE, FLORIDA

Florida Not for Profit Corporation Act, hereby adopt the following Articles of

Incorporation:

ARTICLE I NAME

The name of the corporation shall be: Geneva Historical and Genealogical Society, Inc.

ARTICLE II PRINCIPLE OFFICE

The principle place of business: the Geneva Museum, Seminole County, Geneva, Florida.
