ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF CHRIST COMMUNITY CHURCH OF CAPE CORAL, INC.

FIRST: Amendment(s) adopted:

Title

Article III of the Articles of this corporation is amended to read as follows:

The purposes for which the corporation is organized are exclusively Religious, charitable and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Any additional provisions for the operation of the corporation are as follows:
