

#### **ARTICLES OF INCORPORATION**

#### **PREAMBLE**

We, the undersigned, for the purpose of forming a corporation under the provisions of the State of Florida, do hereby associate ourselves together as a body. In order to establish our work on a more permanent basis, we, the members of the local GRACE PENTECOSTAL CHURCH, assembly at Naples, Florida, affirm our belief that God's people should scrupulously set in order, and that it is needful for them to be efficiently organized to successfully carry on the Gospel work and properly handle their business affairs.

#### PURPOSE

A house divided against itself cannot stand. The purpose of this constitution is to provide rules to govern this assembly, according to the scriptures, so that we may advance in the will of God (Titus 1;5; I Corinthians 12:28). The general purpose of this corporation shall be that of a religious organization, more specifically a Christian congregation, established and maintained not for profit, but for the express purpose of disseminating the Gospel according to the word of God (as stated above); and to provide, erect, own, lease, furnish, or manage any building, hall, parsonage, or other facility for said purpose.

#### ARTICLE I

#### THE ASSEMBLY

#### Section 1. The Name:
