ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF PALM BEACH PANTHERS HOCKEY, INC.

Voting Members

At a duly constituted meeting of the Directors, and Officers of Palm Beach Panthers Hockey, Inc., the following Amendments to the Articles of Incorporation dated June 24, 1999 and filed with the Florida Secretary of State on August 4, 1999, were adopted:

- 1. Article IV, entitled "Purposes", shall include the following:
- D. The purposes for which the Corporation is organized are exclusively charitable and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986.
- E. Notwithstanding any other provisions in these Articles, the Corporation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- 2. The following Article XIII, entitled "Dissolution", shall be added to the Articles:

 In the event of dissolution of the Corporation, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 503(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986, or corresponding Sections of any prior or future Internal Revenue Code, or to the federal, state, or local government for exclusive public use.

The foregoing Amendment was duly adopted at a properly noticed meeting of the Directors, Voting Members and Officers of the Corporation conducted on January 9, 2001.
