ARTICLES OF INCORPORATION  
OF  
TAMPA PEOPLES CHURCH, INC.

Article I

The name of the corporation shall be:

TAMPA PEOPLES CHURCH, INC.

Article II.

The principal place of business and mailing address of this corporation shall be:  
17826 Sunrise Dr., Lutz, FL 33549

Article III

The specific purposes(s) for which the corporation is organized are:

- (a) To establish a Biblical Christian Church to provide and maintain a place of worship of JEHOVAH, the Almighty God, our Heavenly Father, and the Lord Jesus Christ, His only begotten Son, through the Holy Spirit, and the promotion of Christian fellowship, edification, virtues, knowledge and spiritual gifts.
- (b) To license and ordain Christian workers, ministers, teachers, and missionaries to plan and establish branches and indigenous churches and out-reach missions.
- (c) To perpetually protect the local church corporation in its ownership and control of corporate property and its sovereignty under Jesus Christ; therefore all ecclesiastical power and authority to the church and corporate property shall be exclusively exercised by the corporation assembled pursuant to the corporation's Constitution and By-Laws as a congregation, and the decisions thus made are not subject to review or reversal by any other ecclesiastical body whatsoever.
- (d) To earnestly seek and promote the unity of the Body of Christ in the scriptural manner of God's love, mercy and grace.
- (e) To associate and cooperate freely with other church fellowships, denominations, associations, and organizations as a free and independent church in accord with its own free convictions and the wisdom of God as this church perceives itself to be.
- (f) To conduct any and all lawful activity not specifically prohibited to nonprofit corporations by the laws of the State of Florida and to corporations exempt from Federal taxation.
- (g) To publish, distribute and teach Christian written and electronic media material to the members of this corporation and the general public.
