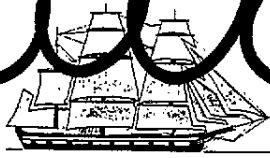

ARTICLE ONE - NAME

THE NAME of this corporation shall be “**The General Conference of The Gospel Navy Church, Inc.**”

ARTICLE TWO - PRINCIPAL PLACE OF BUSINESS

ARTICLE THREE - PURPOSE

THE PURPOSES for which **The General Conference of The Gospel Navy Church, Inc.** is organized are exclusively charitable, and it is the purpose of this corporation to provide leadership and support to the work of the body of believers which constitute the The Gospel Navy Church in preaching the Gospel of Jesus Christ to the whole world, rescue the lost and unchurched, and witness the love of Jesus Christ to the less fortunate.. It is further the purpose of this organization to provide administrative oversight for the operations of the Church. It is further the purpose of this organization to credential qualified individuals as ordained ministers of the Gospel to accomplish the mission of The Gospel Navy Church . Notwithstanding any other provisions of these Articles this organization shall not carry on ANY activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)3 of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE FOUR - MANNER OF ELECTION OF DIRECTORS

THE MANNER of the election of Directors is to be provided for in the Bylaws.

ARTICLE NINE - DISSOLUTION


