

ARTICLES OF INCORPORATION OF

ANGLICAN PROVINCE FOUNDATION, INC. A NONPROFIT CORPORATION



ARTICLE I - NAME

The name of this Corporation is ANGLICAN PROVINCE FOUNDATION, INC.

ARTICLE II - DURATION

This Corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized to act as a nonprofit corporation and organization. The corporation is organized to engage in, and act for exclusively religious, eleemosynary, charitable and education purposes within 'the meaning of § 501(c)(3) and § 170(c)(3) of the Internal Revenue Code, or the corresponding Internal Revenue Law, with the section of any United States primary purpose of aiding , strengthening, and furthering in every proper and useful way the work, programs and services of the Anglian Province of America, Inc., and the Diocese of the Eastern United States (Anglican Church, Inc.). In furtherance of these purposes it shall be authorized and empowered to solicit, receive, maintain, administer, invest, and reinvest, sell, hypothecate both real and personal as well as intangible properties which may become its properties, by will, donation, or otherwise. All such receipts, both principal and income and interest or dividend shall be used and expended exclusively for the purposes and programs of the Province and Diocese herein designated.

Without limiting the generality of the foregoing, the principal purpose of the Foundation shall be to supplement, enhance, and enrich facilities, programs, activities and services of the Anglican Provinces and the Diocese of the Eastern United States (Anglican Church, Inc.).

No part of the earnings of the Foundations shall inure to the benefit of, or be distributable to its trustees, officers, directors or other private persons, except the foundations shall be authorized and empowered to pay reasonable compensation for service rendered in its behalf and to make payments and distributions in furtherance of the purposes set forth above. No substantial part of the foundation shall be the carrying on of programs of propaganda, or otherwise attempting to influence legislation; and the Foundation shall not participate in or intervene in (including the publication or distribution of statements) any political campaigns on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of the activities, the Foundation shall not carry on any other activities not permitted to be carried on (a) by a foundation exempt from Federal Income tax under § 501(c)(3) of the Internal Revenue Code, or the corresponding section of any United States Internal Revenue Law, (b) or by a Foundation, contributions to which are deductible under § 170(c)(3) of the Internal Revenue Code, or the corresponding section of any United States Internal Revenue Law.

ARTICLE IV - MEMBERSHIP

The Rules for Membership in this corporation shall be governed by the By-laws and the Notice requirements to the Members shall be governed by the By-laws.


