ARTICLES OF INCORPORATION

ARTICLE I

The name of the corporation shall be:
Still Waters Church, Inc..

ARTICLE II

The principle place of business and mailing address of this corporation shall be:
Still Waters Church, Inc.

ARTICLE III

The specific purpose(s) for which the corporation is organized are:

1. Envolve and encourage followers of Jesus Christ to regularly attend scheduled church services.
2. Educate people to a knowledge of the God of the Bible and the Jesus of the Bible, God's only begotten Son.
3. Enlist people for christian activity and service through their local church, Still Waters Church, Inc..
4. Edify members in Biblical teachings and practice as presented by Jesus Christ and His apostles. (Heb.4:12; 2 Tim.3:16)
5. Encourage systematic Bible study.
6. Earnestly proclaim the gospel(good news) of Jesus Christ as presented in the Bible.
7. Envelope people with the Love of God as defined in the Bible. (1 Cor.13:4-8,13)

ARTICLE IV

The manner in which the directors are elected or appointed is: The members of the Board of Elders(directors) shall consist of those members of the church who are from time to time appointed to such office with the confirmation of the congregation. Elders will serve a three year term and serve no more than two three-year terms in succession. A Board member elected for two three-year terms shall be inelegible for re-election until one year has elapsed. The Board of Elders shall form the Board of Trustees and shall serve as final authority in the capacity required by the State of Florida.
