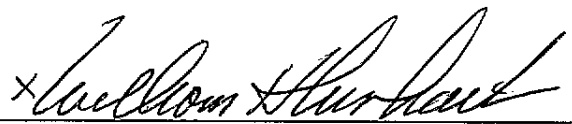

The undersigned, acting as incorporator of a non-profit corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE ONE

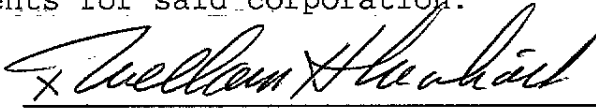
ARTICLE FIVE
