**ARTICLES OF INCORPORATION**  
**OF**  
**ANOMIE PRODUCTIONS, INC.**

**Know all men by these presents**, that the undersigned hereby organize and incorporate for the purpose of forming a body corporate under and by virtue of the laws of the State of Florida, and especially under and by virtue of "CHAPTER 617, CORPORATIONS NOT FOR PROFIT, FLORIDA STATUTES", for engaging in activities with and under the following charter.

**Article I – NAME**

The name of the corporation shall be ANOMIE PRODUCTIONS, INC.

**Article II – Purposes**

The corporation is organized for scientific, educational and charitable purposes; for the purpose of sharing knowledge and allowing participation by all members in:

- A. To provide an organization to facilitate display of artwork and educational exhibitions.
- B. To organize and host special events, exhibitions, projects and workshops that will enlighten the public artistically, educationally, and athletically.

**Article III – Existence**

The corporation is to have perpetual existence.

**Article IV – Subscribers**

The name and Post Office address of each subscriber to these Articles of Incorporation are as set forth at the end hereof and incorporated herein by reference.

**Article V – Management**

The business of the corporation shall be managed, controlled and conducted by a board of directors, consisting of not less than one (1) nor more than fifteen (15) persons, the actual number to be specified in the By Laws. The Board of Directors shall appoint a President, Vice President, Secretary and Treasurer. The President shall serve as the Chairperson of the Board of Directors. Any person may hold two or more offices except that the President shall not also be the Secretary.

Amendments to these Articles of Incorporation shall be first adopted by a simple majority vote of the Board of Directors.

## **Article IX – Principal Office**

The principal office of the corporation shall be located in Brevard County, Florida the following Post Office address: 8595 Eola Court, Viera, FL 32940

## **Article X – Compensation**

No part of the earnings or revenues of the corporation shall inure to the benefit of, or be distributed to its members, officers, directors or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes as set forth in ARTICLE II hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for political office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)3 of the Internal Revenue Code. This may be further limited by the By Laws.

## **Article XII – Miscellaneous**

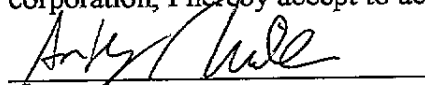
