AMENDMENT TO THE ARTICLES OF INCORPORATION

OF

JESUS IS! MINISTRIES II, INC.

The undersigned incorporator desiring to form a corporation in accordance with 501(c) (3) of the Code, adopts the following Amendments to Articles of Incorporation:

- 1. From the ARTICLE IX, the 2nd paragraph, "The president shall remain in office for the duration of his lifetime" is being deleted from the original Articles of Incorporation.
- 2. The purposes for which this organization is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- 3. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- 4. Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal Tax Code, or shall be distributed to the Federal, State, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.
- 5. No part of the net earning of the organization shall inure to the benefit of any member, trustee, director, officer of the organization, or any private individual (except that reasonable compensation may be paid for services rendered to or for the organization), and no member, trustee, officer of the association distribution of any of the assets of the organization.
- The organization hereby adopts the By-Laws presented and approved.
- 7. The organization hereby adopts an annual accounting period which ends at the end of the calendar year.
