The following articles are to be amended, pursuant to the provisions as set forth in Florida statutes, section 617.1006:

Article III- The purpose for which the Corporation is organized are exclusively religious, charitable and educational in nature within the meaning of section 501(c)(3) of the Internal Revenue code of 1986 or the corresponding provision of any future United States Internal Revenue law.
