Articles of Incorporation

Article I

The name of the corporation shall be: Taylor Made Entertainment, *Incorporated*

Article II

The principle place of business and mailing address shall be: 1837 E. 23rd Street, Jacksonville, Florida 32206.

Article III

The specific purposes of which the corporation is organized are: To engage in the production, promotions and recording of artist talents.

The enumeration of the purposes, subjects and businesses of the corporation is made furtherance and not in limitation of the powers conferred upon the corporation by law and is not intended, by the mention of any particular purpose, subject or business, in any manner, to limit or restrict the generality of any purpose, subjects or businesses mentioned, or to restrict any of the powers of the corporation. The corporation is formed upon the articles, conditions, and provisions expressed and subject in all particulars, to the limitations relative to corporations which are contained in the general laws of Florida.

Article IV

The manner in which the Directors are elected or appointed is provided in the governing By-Laws of the corporation.

Article V

The corporate powers of this corporation are provided in section 617.0302, Florida Statutes.

Article VI


