ARTICLE IV THE MANNER OF DIRECTION OF DIRECTORS:

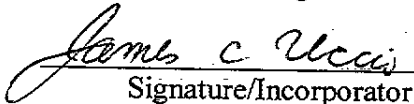
The Board of Directors are nominated and appointed annually by the outgoing Board of Directors. As stated in the bylaws.

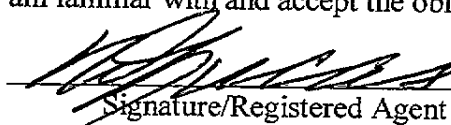
