ARTICLES OF INCORPORATION
OF

CABALLERIA MAMBISA GENERAL FRANCISCO VICENTE AGUILERA, INC.
(NOT FOR PROFIT)

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be:

CABALLERIA MAMBISA GENERAL FRANCISCO VICENTE AGUILERA, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business of this corporation shall be:

15520 S.W. 209TH AVENUE
MIAMI, FL. 33187

ARTICLE III - PURPOSE(S)

The general nature, object, and purpose of this not for profit corporation is as follows: To establish and maintain a place for the families of descendants of all Cubans so that they may come to understand the importance of the CABALLERIA MAMBISA in the battles for Cuba's independence during Spanish Reign in the island, as well as to educate young adolescents about Cuban History and American History so that they may become well informed about their roots. This non profit organization will also emphasize and teach how to adapt to a country farm lifestyle, care for animals such as as horses and other farm animals as well.

ARTICLE IV - MEMBERSHIP

The members of this not for profit corporation shall be all members in good standing at any given time of Florida, provided, however, neither the incorporators nor the members of the not for profit corporation shall have any vested right, interest, or privilege of, in, or to the assets, functions, affairs or franchises of this not for profit corporations, or any right, interest, or privilege which may be inheritable or shall continue after his membership ceases in the aforementioned not for profit corporation. This not for profit corporation shall not have the power to buy, mortgage, or sell, encumber, or deed or dispose of any property which it may acquire, without the consent or the direction of a Two-Thirds (2/3) majority vote of the officers, or its successors. Members are all persons who come to the center at least once a week.

ARTICLE V - TERM

This not for profit corporation shall exist perpetually or until dissolved by due process of the law. Should this not for profit corporation cease to exist as a legal entity and its charter be terminated, title to all its property automatically shall become vested in the conference of LA LIGA CONTRA EL CANCER.

ARTICLE VI - MANNER OF ELECTION OF DIRECTORS (OFFICERS)

The officers who are to manage the affairs of this corporation shall be as follows: A President, Secretary, and Treasurer, all whom shall be the trustees of the not for profit corporation, and such other officers shall be provided for in the by-laws, all of whom shall constitute and be the Official Board of Directors.

They shall be elected from time to time in accordance with the by-laws, and each shall hold office until his successor is elected and qualified, at its regular annual meeting. The President shall sign and the Secretary shall attest all legal

elected and qualified, at it's regular annual meeting. The President shall sign and the Secretary shall attest all legal contracts authorized by the members of this corporation and the laws of the State of Florida.

ARTICLE VII- BY-LAWS

The by-laws of this not for profit corporation are to be made, altered by a majority of the qualified members present and voting at any properly called meeting at which a quorum is present.

ARTICLE VIII- AMENDMENTS

These articles of Incorporation may be amended in the manner provided by law. Every amendment must first be approved by the Official Board Of Directors (trustees), then approved at a duly constituted meeting called for, two weeks in advance, by the members, by a majority of those entitled to vote thereon.

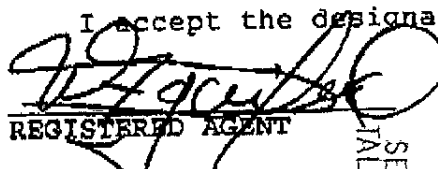
