ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE 1. - NAME

The name of the corporation shall be GRACE COVENANT CHURCH OF SARASOTA, INC.

ARTICLE 2. - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be: 5530 W. Long Common Court, Sarasota, FL, 34235.

ARTICLE 3. - PURPOSES

The specific purposes for which the corporation is organized is to advance the Kingdom of our Lord and Savior Jesus Christ.

ARTICLE 4. - TRANSFER OF ASSETS

If the corporation should ever be dissolved, all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to a non-profit corporation, or other organization, which has qualified for exemption on Section 501(c)(3) of the Internal Revenue Code, or any regulation relating

to said section. The members of the corporation who are members in good standing at the time of dissolution of the corporation, shall, in conference sitting, designate the non-profit corporation or corporations to receive said assets of the corporation after dissolution. None of the assets of the corporation shall be distributed to any member, officer or trustee of the corporation.

ARTICLE 5. - MANNER OF ELECTION OF DIRECTORS/MEMBERS

The method of election of directors/members shall be stated in the bylaws.

ARTICLE 6. - INITIAL REGISTERED AGENT AND STREET ADDRESS

The street address of the corporation's initial registered office is 2033 Main Street, Suite 600, Sarasota, Florida, 34237, and the name of the corporation's initial registered agent at such address is Icard, Merrill, Cullis, Timm, Furen & Ginsburg, P.A. (Attention: Michael L. Foreman).




