The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is **DELRAY BUSINESS ASSOCIATES, INC.**

ARTICLE II - PRINCIPAL OFFICE

The power to adopt, amend, alter, rescind or repeal the Bylaws shall be vested in the Board of Directors and the members.

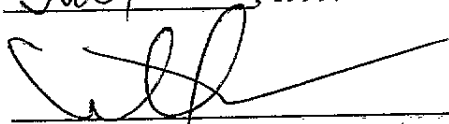
ARTICLE VIII - INDEMNIFICATION

This Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

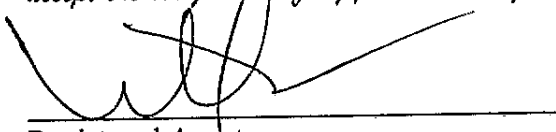
ARTICLE IX - AMENDMENT

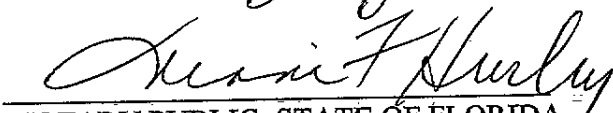
