The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt (s) the following Articles of Incorporation:

ARTICLE I NAME:

The name of the corporation shall be: **Animal Rescue Fund, Inc.**

ARTICLE II PRINCIPAL OFFICE:

The principal place of business and mailing address of this corporation shall be:
665 Rosemere Circle, Orlando, Florida 32835

ARTICLE III PURPOSE:

The specific purpose for which the corporation is organized is **to provide food, shelter and medical attention for homeless animals. We will also emphasize spaying and neutering homeless animals to help control the population of unwanted animals as well as educating the public on the importance of spaying/neutering for the health of the animal and as a way of lowering euthanasia as population control.**

ARTICLE IV MANNER OF ELECTION OF DIRECTORS:

The manner in which the Directors are elected or appointed shall be by written ballot. At such election, the current Directors will cast a vote. The names receiving the largest number of votes (without regard to Class) for each vacancy shall be elected.
