The undersigned, acting as Incorporator of a corporation under the Florida Not For Profit Corporation Act, adopt the following Articles of Incorporation of such corporation:

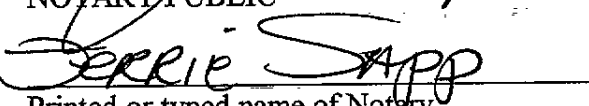
