ONE: The name and address of this principal corporation is **Eyes of Faith Christian Academy, Inc.**, 1925 NE 45th Street, Fort Lauderdale, Florida 33308, Broward County. The corporation is organized pursuant to **FLORIDA** Non-profit Corporation Code.

TWO: This corporation is a non-profit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Non-profit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of, but shall not be limited to: Caring for Children ages 6 weeks to 10 years, Planned Activities for all age groups (which will consist of a well balanced curriculum, classes being taught from Christian Based Books), Counseling for Children, Counseling for Parents, Family and Marriage Counseling, After School Activities and other programs to aid those in need.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.
