

ARTICLES OF INCORPORATION



Commitment to Rec overy, Inc

For the purpose of forming a corporation under the Florida Not for Profit Corporation Act, the incorporator hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation is <u>Commitment to Recovery</u>, <u>Inc</u>.

ARTICLE II. PRINCIPAL OFFICE

Notwithstanding any other provision of these Articles, this corporation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Sec 501(c)(3); or by a corporation contributions to which are deductible under Sec 170(c)(2) of the Internal Revenue Code of 1986 or the corresponding section of any future Internal Revenue Code provision.

No part of the activities of the corporation shall be for propaganda or otherwise attempting to influence legislation, and the corporation will not participate or intervene in any political campaign on behalf of or in opposition to any candidate for public office, including but not limited to publishing or distributing statements.
