WE, THE UNDERSIGNED, do hereby associate ourselves together together the purpose of forming a non-profit corporation, under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liabilities, rights and privileges and immunities of corporation for non-profit, certifies that:

ARTICLE 1 - NAME

The name of the corporation shall be :

RABBI MARC BENARROCH, INC.

ARTICLE II - EXISTENCE

This corporation shall have perpetual existance commencing on August 16, 1999.

ARTICLE III - ADDRESS

This Corporation shall be located and have its principal office at 17720 N. Bay Road, PHA Miami Beach, Florida 33160

ARTICLE IV - PURPOSE

This corporation is organized for the purpose to wit:

A- Charitable, Educational and all lawful and religious business permitted under the Laws of the United States and of this State.

B- Independent charitable organization, which have voluntarily joined together, including but not limited to a united fund or community chest, for purposes of raising and distributing money for and among themselves and where membership does not confer operating authority and control of the individual agencies upon the federated group organization.

C-This charitable organization which intends to solicit contributions within this state, or have funds solicited on its behalf, shall prior to any solicitation, file a registration statement with the department of state upon forms prescribed by it.

D-Elect or appoint such offers and agents as its affairs shall require and allow them reasonable compensation.

E-Adopt, change, amend and repeal By-laws, not inconsistent with law or its Articles of Incorporation, for the administration of the affairs of the corporation and the exercice of its corporate powers.

F-Increase, by a vote of its members cast as the By-Laws may direct, the number of its directors, managers or trustees so that the number shall not be less then 3 but may be any number in excess thereof.

G-Make donations for the public welfare or for religious, charitable, scientifie, educational or other similar. purposes.

Receive donations as charitable from members or non members of this Organization.

ARTICLE V - TERM

The term of existance of this corporation shall be perpetual.

ARTICLE VI Memberships

The membership of this corporation shall be open to all people of all ages interested in perpetuating Sephardic or Ashkenazim culture and tradition.
