

OF

- ONE: The name and address of this principal corporation is La Gree Community Outreach Agency, Inc. located at 2021 NW 28th Street, Ft. Lauderdale, Florida 33311, Broward County, Florida. The corporation is organized pursuant to FLORIDA's Non Profit Corporation Act.
- TWO: This corporation is a non profit charitable and educational organization organized established to provide, but is not limited to the following services: Child Care, Youth and Adults at High Risk, Tutorial Services; Emergency Financial Assistance; Job Readiness and Referral for Seniors and Teenagers; Intensive Case Management; Sign Language for Hearing Impaired; Employability Training; Parenting Tutorial Services; Computer Lab; After School Programs for Teenagers; Pre-teen Self-Esteem Courses; Seniors Work Partnership, Job Placement and Mentorship Programs; 23 Hour Learning Academy
- THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.

Articles of Incorporation of La Gree Community Outreach Agency, Inc.

- (a) This corporation is organized and operated exclusively for charitable and educational purposes within the meaning of 501(C)(3) of the Internal Revenue Code.
- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contribution to which are deductible under Section 170 (c)(2) of the Internal Revenue Code.

FIVE: The Board of Trustees are elected in accordance with the Bylaws. The name and address of the persons appointed to act as the initial Trustees of this corporation are:



All articles or amendments of the corporation shall be terminated, if at any time be in conflict with the teaching of Jesus Christ. The above articles are in accordance with the 1st and 14th amendment of the U.S. Constitution.
