# ARTICLE OF INCORPORATION

We, the undersigned, hereby associate ourselves for the purpose of becoming a non-profit corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the information, liability, rights, privileges and immunities of a corporation not for profit.

## ARTICLE I

### Name of Corporation

It is founded in Boca Raton, on March 1, 1999 and the group called: "EVANGELICAL UNION OF FISHERMEN, INC."

## ARTICLE-II

### Purpose

Our purpose is to preach the gospel on every occasion for the salvation of all human beings. We have the following objectives:

- 1) Organize missionary tours where about USA and abroad.
- 2) Spread out the gospel at dawn.
- 3) Advise and sustain evangelical leaders for the fulfillment of their duties.
- 4) Encourage and provide training for the fresh adepts.
- 5) Giving lectures on both biblical and social issues.
- 6) Organize general training seminars.
- 7) Provide assistance to Christians facing hardship of life.
- 8) Organize revivals in evangelical churches.
- 9) Organize evangelical crusades in public areas.

## ARTICLE-III

### Qualification of the Members

Each member is obligated to the principles of the bible in order to live accordingly to God.

His or her position should comply with the rules and regulations; otherwise punishment will be inflicted upon.

Any member who insists on violating the principles and whose life is not compatible to the word of God will be

declined of being part of the group. Each one who complies with the terms of articles, will be issued a card

member and they should regularly contribute financially to the fund of the group.

Evangelical Union of Fishermen recognizes two categories of members:

- Active members
- Supporter members.

A. Active members are those who are involved in all our activities.

B. Supporter members contribute economically and morally to the progress of **Evangelical Union of Fishermen, Inc.**

To become a member of **Evangelical Union of Fishermen, Inc**, the applicant must:

- a) Be a member no less than one calendar year of an evangelical church.
- b) Be of a good standing status in the Christian and non-Christian community.
- c) Be committed to God and to his work field.
- d) Not practice game of chance and usury.
- e) Obey laws and by-laws of **Evangelical Union of Fishermen**.

## ARTICLE-IV

### By-Laws

By laws of the corporation are to be made, offered, and rescinded by a majority of the qualify members of the **Evangelical Union of Fishermen, Inc**, present and voting at a regular or special business meeting.

## ARTICLE-V

### Corporate Existence

The headquarters of **Evangelical Union of Fishermen, Inc** is in Boca Raton, the location of its foundation. However, it can be transferred somewhere else on full consent of the majority of the Executive board members. The lifetime duration of **Evangelical Union of Fishermen, Inc** is limitless unless sooner dissolve by law.

## ARTICLE VI

### THE MANNER OF ELECTION OF DIRECTORS IS STATED IN THE BY-LAWS

A President, a Vice President, a Secretary and a Treasurer, as authorized by the **Evangelical Union of Fishermen, Inc** shall manage the affairs of the corporation. Said the officers of the **Evangelical Union of Fishermen, Inc** shall be elected at the general assembly by a majority vote of the members. The President shall serve until such time as he resigns, or is removed. The officers shall serve until such time as they resign or their successors are elected. These shall be:

6-1 The President has the duties to Preside and supervise the **Evangelical Union of Fishermen, Inc** activities.

6-2 The Vice President is acting as the President in times of absence.

6-3 The secretary takes the minutes when having meeting, is responsible for correspondences, holds the archives and signs in and out document of **Evangelical Union of Fishermen, Inc**.

6-4 The treasurer has the control over all financial issues of **Evangelical Union of Fishermen, Inc** and CO-signs all related documentation.

6-5 The adviser gives away advises and settles all potential disputes.

## ARTICLE-VII

### Departments

**Evangelical Union of Fishermen, Inc** contains many departments as of:

- a) Evangelism
- b) Predication
- c) Evangelical crusades
- d) Training.

## ARTICLE VIII

### Funds

## ARTICLE-XI

### Amendment

These Articles of Incorporation may be amended in the manner provided by law. The Board of Directors shall approve every amendment at a meeting in which a quorum shall be present.

## ARTICLE-XII

### Principal Place of Business

The initial post office address of the principal office of this corporation in the State of Florida is 250 Manchester Street. Boca Raton, FL 33487. The Board of Directors may from time to time move the principal office to any other address in Florida and establish branch offices at any other place within or without the State of Florida.

## ARTICLE-XIII

### Dissolution

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501 ( c ) ( 3 ) and 170 ( c ) ( 2 ) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or Local Government for exclusive public purpose, and in accordance with the by-laws and Constitution of the EVANGELICAL UNION OF FISHERMEN, INC.

ARTICLE XIV

Prohibited Activities


Notwithstanding any other provision of the articles, this corporation shall not carry on any other activities not permitted to be carried on by ( a ) a corporation exempt from Federal Income Tax under Section 501 ( c ) ( 3 ) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Revenue Law or ( b ) a corporation's contributions which are deductible under 170 ( c ) ( 2 ) of the Internal Revenue Code of 1954 or any other corresponding provisions of any future United States Internal Revenue Law.

ARTICLE XV


Resident Agent





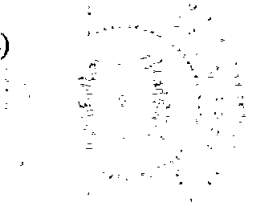
