EXHIBIT "A"

PURPOSE: The purpose for which The Least of These Church, Inc., are as follows:

- (a) To establish a church with regular assemblies for worship and discipleship, to evangelize our communities our nation and the world, and to assist evangelist, national church leaders and missionaries in a variety of ways such as evangelistic ministry with the opportunity for personal evangelism and literature distribution throughout the United States and abroad in furtherance of these stated purposes;
- (b) To establish and operate a medical/dental relief agency dedicated to providing assistance to poor and disadvantaged people in the United States and abroad;
- (c) To procure, purchase, or otherwise obtain food, clothing, medical and dental supplies, and other necessities and to distribute and dispense such supplies to homeless and hungry children and to indigent and impoverished families within the communities in which this church has facilities;
- (d) To ordain ministers for the work of the Gospel;
- (e) To design and conduct business, social, educational, athletic, charitable, and any other moral, legal and Christian programs necessary to support the goals of The Least of These Church, Inc.;
- (f) To lease, acquire, either by deed, gift or purchase, any real estate or personal property to be held by the Church for the benefit of the Corporation and its stated purpose;
- (g) To mortgage, sell, or otherwise encumber any such property when such action is deemed to be in the best interests of the Corporation as defined in its stated purpose as a Christian organization;
- (h) To make distributions to organizations that shall qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code as defined in its stated purpose as a Christian organization.
